



ABS Labour Force Results – October 2024

The data in this document are sourced from ABS, Labour Force, Australia, October 2024 and are in seasonally adjusted terms (unless stated otherwise). Note that changes are calculated from more detailed data and may be different from, but are more accurate than, changes calculated manually from the figures presented in the text and tables.



The latest ABS *Labour Force Survey* (LFS) results continue to reflect the underlying resilience of the Australian labour market. Indeed, **employment** increased by 15,900 over the month (although this was at the lower end of market expectations), to stand at a record high of 14,537,500 in October 2024, and is now 387,100 (or 2.7%) above the level recorded 12 months ago. It is worth noting that *annual* employment growth has continued to outpace growth in the civilian population, which increased by (a still strong) 2.5% over the year.

• Abstracting from the volatility inherent in the monthly estimates, the pace of *trend* employment growth has gradually softened, from its recent peak of 44,800 in July 2024, to (a still strong) 36,800 in October 2024.

While the **unemployment rate** remained steady over the month, at 4.1% in October 2024, it has nonetheless increased by 0.3 percentage points over the *year*. The **participation rate** declined marginally¹ over the month, to stand at 67.1% in October 2024 (just below the record high of 67.2% in September 2024), but is 0.3 percentage points above the rate recorded a year ago.



¹ More detailed data show that the participation rate fell marginally, from 67.175% in September 2024, to 67.135% in October 2024, which equates to a change of 0.0 percentage points when rounded to one decimal place.

Full-time employment increased by 9,700 over the month, to stand at a record high of 10,037,700 in October 2024, and has risen by 237,100 (or 2.4%) over the year.

Part-time employment also rose over the month, by 6,200, to stand at a record high of 4,499,800 in October, and has risen by 150,000 (or 3.4%) over the year.


Part-time employment and total employment were at a record high for women in October 2024, while full-time employment and total employment were at a record high for men.

The employment to population ratio stood at an equal record high of 64.4% in October 2024, and is 0.1 percentage points higher than it was a year ago.

The employment to population ratio for males remained steady over the month, while it fell by 0.1 percentage points for females over the same period.





Hours worked rose by 2.9 million hours in October 2024 and are now 47.6 million hours (or 2.5%) above the level recorded a year ago.

Male hours worked rose by 1.0 million hours (or 0.1%) in October 2024, to stand at a record high, and female hours worked increased by 2.0 million hours (or 0.2%) over the same period.

The underemployment rate fell by 0.1 percentage points over the month, to 6.2% in October 2024, but is 0.4 percentage points above its recent trough in February 2023.

The male underemployment rate fell by 0.1 percentage points in October 2024 and the female underemployment rate declined marginally, by 0.1 percentage points over the month.

The unemployment rate was steady in October, at 4.1%, but is 0.3 percentage points higher than it was a year ago.


The male unemployment rate rose by 0.1 percentage points over the month, while the female unemployment rate was steady over the same period.







Employment for young people increased by 11,800 over the month, to stand at record high of 2,262,800 in October 2024.

The youth unemployment rate rose marginally over the month, to 9.2%, but is 0.2 percentage points lower than it was a year ago.

The youth participation rate rose by 0.7 percentage points over the month but is 0.2 percentage points below the rate recorded in October 2023.

Employment rose in 3 jurisdictions in October 2024, with Queensland recording the largest increase (of 38,000) followed by South Australia (up by 7,000). New South Wales recorded the largest fall in employment over the month (of 18,900), followed by Tasmania (down by 2,700). Employment stood at a record high in Queensland and South Australia in October 2024.

The unemployment rate rose in 5 jurisdictions in October 2024, with only 2 jurisdictions recording an unemployment rate below 4.0%. The Australian Capital Territory recorded the lowest unemployment rate (of 3.1%), followed by Queensland (of 3.9%), while the Northern Territory recorded the highest unemployment rate (of 4.6%).

The participation rate rose in 4 jurisdictions over the month, with the largest increase recorded in Queensland (up by 0.6 percentage points). The Northern Territory recorded the highest participation rate (of 72.6%), followed by The Australian Capital Territory (of 72.3%), while Tasmania recorded the lowest participation rate (of 60.1%).

New South Wales recorded the lowest *youth* unemployment rate (of 8.6%) in October 2024, while Victoria and Tasmania together recorded the highest youth unemployment rate (of 10.5%), followed by Western Australia (at 9.8%) – see table, overleaf.
